1. This Agreement constitutes a fully-integrated contract concerning the subject matter hereof, and all prior representations, negotiations, or understandings are subsumed herein. This Agreement may be modified or amended only by a writing, signed by the parties. If any provision of this Agreement is held invalid or unenforceable by any tribunal or court of competent jurisdiction, such invalidity shall not affect the validity or enforceability of the remaining provisions of this Agreement. The captions contained in this Agreement are for convenience only.
2. All terms and conditions of this agreement will bind and benefit BTB, Owner, any other owner of the pet, and the heirs, administrators, personal representatives, successors and assigns of each of them.
3. This agreement supersedes any prior agreements between the parties regarding the subject matter of this agreement
4. If any provision of this agreement is held to be invalid or unenforceable, the balance of this agreement will continue in full force and effect, to the fullest extent permitted by law or equity.
5. This agreement will be governed by the laws of the State of Massachusetts, without any reference to principles of conflicts of laws. Should a lawsuit be initiated by either party, the Parties hereto agree to bring said claim in a court of competent jurisdiction located in Plymouth County, Massachusetts. The non-prevailing party agrees to pay the prevailing party's reasonable attorney's fees and costs.

I understand that before my dog enters the BTB premise, I must provide written confirmation from my vet that my dog is current on all core vaccines (Rabies, DHLPP and Bordetella), and that my dog is spayed/neutered.

# Buck Teeth Boarding New Member Agreement

This agreement (the "Agreement") is made between Buck Teeth Boarding (hereinafter called "BTB") and the pet owner, whose signature appears below (the "Owner"), which both parties agree to follow:

## **PAYMENT FOR SERVICES:**

1. Owner will pay, at the established rates of BTB, all costs and charges for all boarding, veterinary, and other services and goods provided for the pet by BTB. All pre-determined costs and charges due from Owner to BTB will be paid in full at the beginning of each visit. A deposit of 20% is due upon making a reservation. BTB will have the right to refuse the release of the pet to Owner until all outstanding costs and charges have been paid in full. Cash is preferred; however, check, PayPal, Zelle and Cash App are accepted.
2. If Owner fails to pick up the pet on its scheduled checkout date, or the pet is not released to Owner because of Owner's failure to pay all cost and charges owed to BTB, BTB shall continue to provide the pet any or all of the services contemplated by this agreement and Owner will be obligated for the payment of those cost and charges at the then-current rates of BTB.
3. Owner will pay a fee of \$20.00 for any returned or dishonored check issued to BTB.
4. **There is an additional charge of \$10 for the following days for overnight boarding:**

## **PET HEALTH SERVICES**

1. If at any time BTB determines that it is necessary to engage the services of a veterinarian, administer medication, or give other treatment or necessary attention to the pet, BTB may do so and Owner will pay all costs and expenses incurred for such veterinarian services, medication, or other necessary attention provided to the pet. Such payment will be made immediately upon the request of BTB, but in any event not later than the end of the pet's visit. Owners also authorize BTB to immediately charge any credit card belonging to Owner with BTB for any charges for veterinary services, medicine, treatment or other necessary attention provided to the pet during its visit.
2. If BTB determines that the pet was brought to the facility infested with fleas or ticks, BTB may provide to the pet any medication, bath or other necessary treatment and Owner will pay all cost and expenses for such medication, bath or treatment and be charged \$75.

## ABANDONED PETS

1. Abandoned Pets. If the Owner fails to pick up the pet within five (5) days of its scheduled checkout date, or BTB has not released the pet to Owner within five (5) days of its scheduled check out date due to non-payment, BTB may, at its discretion, send to Owner a written notice stating that if Owner fails to pay all outstanding costs and charges owed to BTB and pick up the pet from BTB within ten (10) days of the date of such notice, the pet will be deemed to be an "Abandoned Pet." The notice to Owner will be sent by certified mail through the United States Postal Service to the most current address of Owner on file with BTB. BTB may, at its discretion, place any Abandoned Pet with any humane society, animal shelter, or animal rescue group. Owner, or owners agents, heirs, and assigns will have no further ownership right or other claim with the respect to any Abandoned Pet and hereby releases BTB, its members, managers, customers, guests, invitees, agents and contractors, and all other persons or entities (including any agency, shelter or person receiving ownership or possession of the Abandoned Pet) from any claims, loss or liability regarding the Abandoned Pet or BTB's care, treatment or disposition of the Abandoned Pet.
2. Notice, Waiver, Liability. Owner hereby waives any statutory right to notice or other rights of Owner regarding any Abandoned Pet provided under applicable law. Notwithstanding the foregoing, BTB may, at its discretion, exercise any rights and remedies regarding any Abandoned Pet provided under applicable law in addition to or in lieu of its rights and remedies under this Agreement. No actions of BTB regarding any Abandoned Pet will relieve Owner of any liability for any outstanding cost or charges owed to BTB regarding the abandoned pet.

## MEET & GREETES

Meet & greets are by appointment only and are **Mandatory**.

**Owner attests that they have seen the house and yard, whether via live or in photos, and acknowledge the fence height is 4', that their dog will not jump over, go through or go under said fence and is safe for the wellbeing of their dog. BTB is not responsible for these occurances.**

## VACCINE REQUIREMENTS

We require all guests to be up to date on their Distemper, Rabies, and Bordetella vaccines. While the Rabies and Distemper vaccines are yearly, we require the Bordetella vaccine every six months. Vaccines must also be up to date before a temperament test can be done.

**OWNER'S WARRANTIES AND REPRESENTATIONS.** Owner warrants and represents to BTB that:

1. Owner is the sole owner of the pet, free and clear of any claim, lien or encumbrance, and has full power and authority to enter into this Agreement.
2. All information provided by Owner regarding the pet is accurate and complete and Owner has fully disclosed to BTB any pre-existing illness, injuries, or behavioral problems or conditions regarding the pet.
3. The pet has not been exposed to rabies, distemper, or any other contagious disease within the sixty (60) days prior to any stay at BTB.

4. Each of Owner's warranties and representations will be true and correct during all present and future visits by the pet.

## **LIABILITY OF BTB**

1. BTB will at all times exercise reasonable care for the pet while at BTB.
2. Owner hereby releases BTB, its members, managers, shareholders, directors, officers, employees, customers, guests, invitees, agents, and contractors from all claims, costs, expenses, suits and causes of actions, including attorneys' fees and court costs, related to any illness, injury, loss or death to the pet which occurs while the pet is in the care, custody or control of BTB, or which occurred as a result of the care of, BTB, except those caused solely by gross negligence or willful misconduct of BTB.
3. In no event will any liability of BTB to Owner exceed the lesser of: (i) the current chattel value of a pet of the same species and breed; or (ii) \$400.00.
4. BTB will not be liable for any damage to or loss of any personal items left by Owner with BTB.

## **LIABILITY OF OWNER; INDEMNIFICATION**

1. Owner will be solely responsible for the behavior and actions of the pet while at BTB.
2. Owner will indemnify, hold harmless and, if requested by BTB, defend BTB and its members, managers, shareholders, directors, officers, employees, customers, guest and invitees, from and against all claims, cost, expenses, suits and causes of action, including attorneys' fees and court cost, arising from or related to: (i) the behavior and actions of the pet while at BTB; (ii) any injuries to the pet, any other pets or any person, or damage to BTB or other property, caused in whole or in part by the pet; (iii) any breach by the Owner of any term or condition of this agreement; and (iv) the falsity of any warranty or representation made by Owner to BTB.
3. Owner's obligations hereunder to indemnify, hold harmless and defend will survive any termination or expiration of this Agreement.

## **PHOTOGRAPHIC AND VIDEO RELEASE**

1. BTB, its agents, licensees and news agencies may from time to time photograph, videotape or record images of the pet in connection with the business of BTB and all such images will be sole and exclusive property of BTB or such other parties.
2. BTB, its agents, licensees and news agencies may publish, copyright or use any images or recording of the pet (including, without limitation, publishing the images or recording on any website), identify or use the name of the pet and alter any image or recording of the pet including, without limitation, for commercial purpose, without an consent or approval of, or compensation to, Owner.
3. Owner releases and discharges BTB and its members, managers, shareholders, directors, officers, employees, customer, guests, invitees, agents, contractor, licensees and news agencies from all claims, suits and liabilities related to the creation, publication and use of any image or recordings of the pet, including, without limitation, any claims, suits and liabilities for libel or invasion of privacy.

## **AGGRESSIVE DOGS/RE-BOARDING**

1. BTB will do its best to gauge the temperament of new dogs.
2. Owner certifies that their dog has never harmed or shown aggressive or threatening behavior towards any person or other pet.
3. BTB reserves the right to find an alternate boarding facility if a dog shows signs of aggression to any person or dog or bites a person or another dog.
4. Owner agrees to pay all expenses incurred by BTB to re-board their dog.
5. Owner agrees to pay any vet and/or medical bills incurred as a result of their dog harming another dog or person.
6. BTB agrees to **refund 50%** of remaining scheduled boarding days at BTB.

## RULES & INFO

### DROP OFF/PICK UP WINDOWS:

M-F 9:00 am-7:00 pm

Sat-Sun 9:30am-7:00pm

\$15 per 60 minutes earlier

### BOARDING:

Boarding check out is at 1:00pm. Boarding dogs picked up after 1:00pm on departure day will be charged \$10 per hour until pick up.

\$65 per night per dog; One-night stays are +\$10.

Puppies under 1 year of age AND Unspayed/Unneutered dogs are EACH an additional \$15 charge per night.

Dogs require a Mandatory Meet & Greet. If this is not possible there is a \$50 charge.

Dogs 50+ lbs are \$70+ per night. Dogs 70+ lbs are \$75/night. Dogs 80+ lbs are \$80+/night.

### VACCINES:

If your dog off is not current on vaccines at the time of drop off, BTB staff may refuse to accept the dog or will take him/her to the vet for you and you will be charged the cost of the vaccination plus an additional \$100 transportation fee.

### FOOD & WATER:

If you don't provide food for your dog while boarding he/she will be fed "house" food at a cost of \$3.00 per meal.

Water is available inside, on the deck and in the yard at all times.

### MISCELLANEOUS:

**Boarding sometimes includes rough play. Although dogs are monitored, scratches and cuts may occur.** If a dog is injured so as to warrant medical attention, BTB shall take the dog to the nearest veterinarian, regardless of owner's preference, and obtain all medical services necessary. BTB may bill the Owners of any pets involved for any expenses incurred.
